



## Campbell County School District 2019 Summer Driver's Education

April 3, 2019

Campbell County School District will offer two sessions of summer Driver's Education. The courses will be held at Campbell County High School and are open to all students who have a valid license or permit at a cost of \$150 per person. Students will be accepted in order of oldest first, and each session has a limit of 54 students.

Session I: June 3 – June 28

Session II: July 8 – August 2

The first week of class will be required classroom instruction. The remaining 18 hours of driving and observation time will be scheduled with instructor.

Expectations for the course are as follows:

- **PERMIT:** Students must have a valid, state issued driving permit.
- **ATTENDANCE:** Students are not allowed to make up any missed sessions. This is due to the short amount of time this course is offered. It is crucial to make it to all classes and driving sessions. Emergency situations will be considered and appropriate actions taken to make up any missed work and driving sessions.
- **WRITING MATERIALS:** Students will need to bring writing materials with them to every class! This includes a notebook and pencil!
- **SAFETY:** Safety within the vehicle is imperative to all participants in the course. Even if a student is not driving, their cooperation is necessary for everyone's safety! The instructors want everyone to go home safely at the end of the day.
- **RULES:** All CCSD Rules and Regulations apply.

By April 24, any interested student must turn in a completed application to the business office at the student's high school. CCSD personnel will prioritize applications by date of birth and contact students who are eligible. Those selected must pay the \$150 fee by May 10.
